Gaining traction, but is yet to shift into the high gear

APONTIS Q2 results arrived in line with our expectations (€ 12.7m sales € 1.1m EBITDA) showcasing that the ongoing **business transformation and operational turnaround are fully on track**. This is reflected in dynamic Single Pills sales growth and positive EBITDA (and net income) contribution in Q1 and Q2.

Single Pills sales grew by 65% yoy (+ € 3.6m) in Q2 to € 9.1m, carried by the rebound of Atorimib (+ € 3m) after facing tender headwinds and supply bottleneck and the remaining portfolio of Single Pills (+ € 1.3m). At the same time, Tonotec declined by € 0.8m in Q2, which is € 0.4m better than what was expected. Evidently, **the “younger” Single Pills in the portfolio demonstrate a robust growth**. In fact, adjusted for Tonotec (-27% yoy; ~13% of SP sales) and Atorimib sales (+109% yoy; ~48% of SP sales), **the remaining portfolio grew by 49% yoy (+ € 2.2m) in H1**. This reflects the new holistic approach to commercialisation, incl. the revamped go-to-market strategy, intensified collaboration with insurers and medical community.

As the new go-to-market strategy continues to gain momentum, **this robust growth can be leveraged across the rapidly growing portfolio of Single Pills**. The company will add three more pills in Q4'24 to the total of 18 and another two in '25E. Importantly, the **Single Pills portfolio** (incl. expected launches) **is in a great shape with no visible immediate competitive threats**.

What's more, the newly signed Novartis cooperation is a **“gold mine” with the potential to become a multi-year earnings surprise driver** – to a very small extent reflected in our estimates. The cooperation spans over 5 years for two patent-protected and very competitive asthma products **that should go a long way with a concentrated marketing effort**. Unlike the AZ fee-for-call cooperation with no upside, the performance-based structure here ensures **direct participation on the commercial success**, which could yield a significant earnings upside for APONTIS.

The expected € 8-9m (€ 12-13m annualized) sales for 2024E would conservatively amount to **no more than 3% market share** (eHAIB) and **represent a fraction of the competing products' sales** (i.e. Symbicourt, Relvar, Trimbrow), highlighting the strong potential. By 2027E, we model asthma sales of just € 15m yielding c. € 3.5m EBITDA. **Sales of € 20-40m would translate into € 7 to € 18m EBITDA** (eHAIB).

In light the excellent backdrop for a dynamic earnings growth, **9x EV/EBIT'25E looks highly attractive. BUY with € 16 PT** based on DCF.

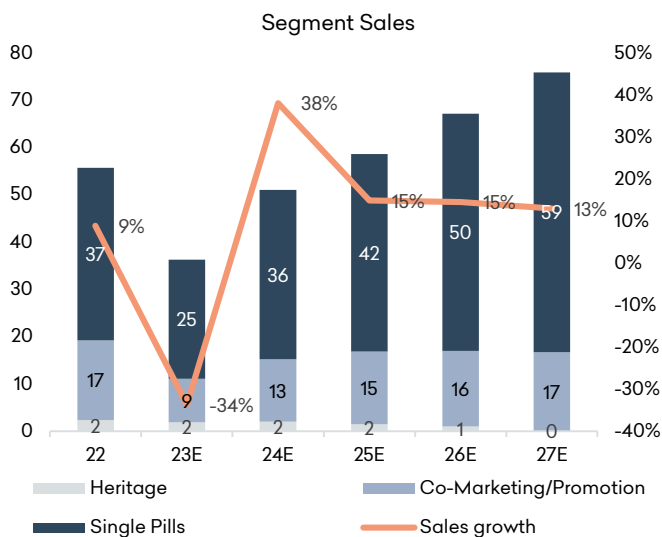
Upcoming Catalysts

- Faster ramp up of individual Single Pill brands, helped by the enhanced go-to-market strategy
- Likely FY 2024E guidance raise/beat
- Better-than-expected ramp up of the Novartis cooperations

Investment Case

- After the “perfect storm” of tender- and supply-related headwinds, the new leadership re-sized the cost base and enhanced the go-to-market strategy.
- The recent results indicate a return to top-line growth and EBITDA profitability in 2024E with a number of upside catalysts outside of the guidance.
- Thanks to the new go-to-market strategy, rapidly growing Single Pill portfolio and reduced break-even sales level, EBITDA is set to grow dynamically into FY27E to € 14m (eHAIB).
- Trading on 6x EV/EBITDA'25E against the expected 46% EBITDA CAGR 2025-27E, the ongoing turnaround is nowhere closed to be priced in. BUY with € 16 PT based on DCF.

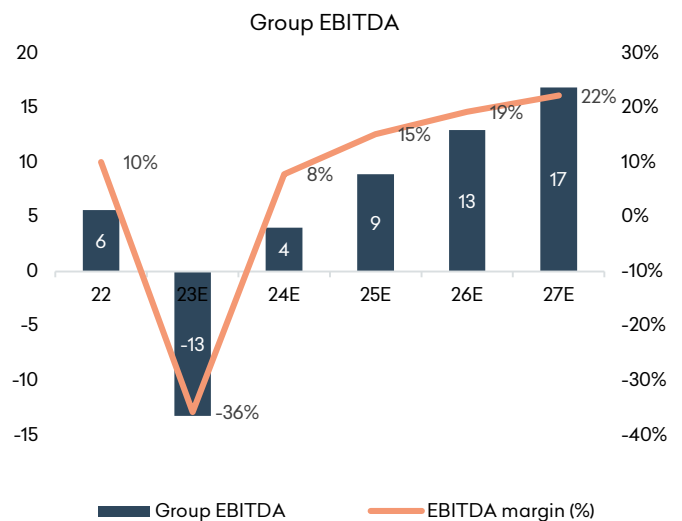

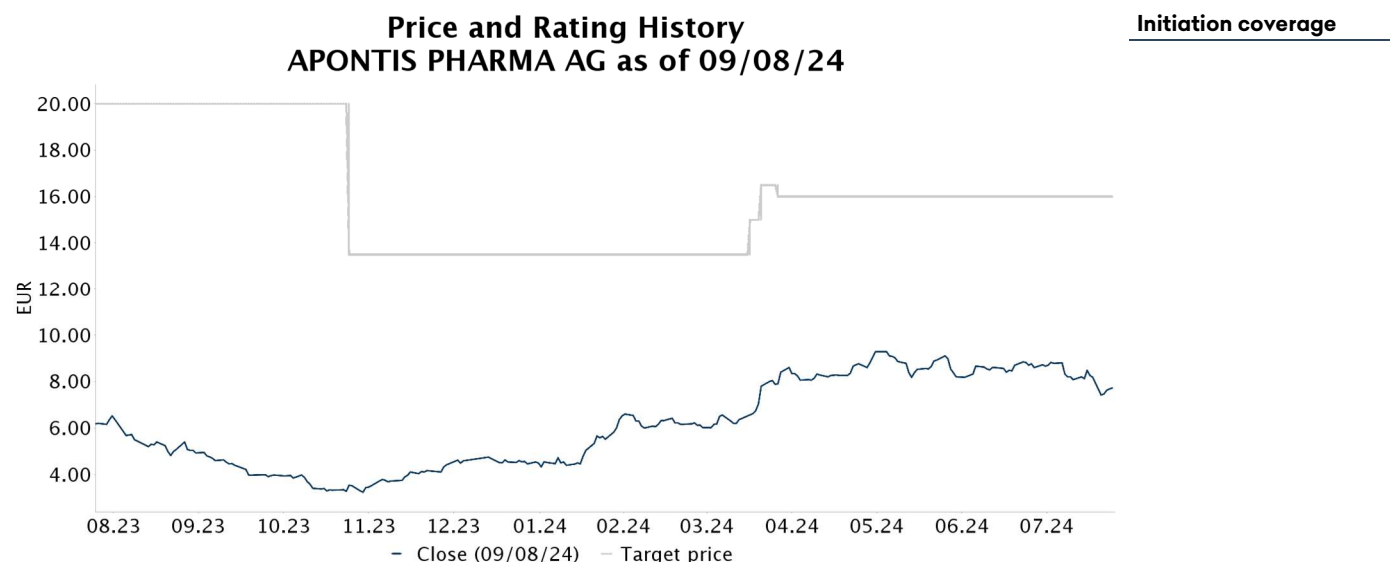

The determination of the fair value per share, i.e. the price target, and the resultant rating is done on the basis of the adjusted free cash flow (adj. FCF) method and on the basis of the discounted cash flow – DCF model. Furthermore, a peer group comparison is made.

The adj. FCF method is based on the assumption that investors purchase assets only at a price (enterprise value) at which the operating cash flow return after taxes on this investment exceeds their opportunity costs in the form of a hurdle rate of 7.5%. The operating cash flow is calculated as EBITDA less maintenance capex and taxes.

Within the framework of the DCF approach, the future free cash flows are calculated initially on the basis of a fictitious capital structure of 100% equity, i.e. interest and repayments on debt capital are not factored in initially. The adjustment towards the actual capital structure is done by discounting the calculated free cash flows with the weighted average cost of capital (WACC), which takes into account both the cost of equity capital and the cost of debt. After discounting, the calculated total enterprise value is reduced by the interest-bearing debt capital in order to arrive at the equity value.

Buy: Sustainable upside potential of more than 10% within 12 months
